


# Overview of the Child Fatality Prevention Team (CFPT)

- NC CFPT collects information on all deaths involving children ages 0-17 who are residents of the state and fall under the Medical Examiner's jurisdiction
- Manner of death is classified as accident, homicide, natural, suicide or undetermined
- Case information for the review is obtained from investigative reports, toxicology reports and autopsy reports, as well as from law enforcement, medical records, DSS, and other agencies
- During the review, CFPT works to identify system gaps, deficiencies, and risk factors
- Obtain data and provide statistical analysis relating to child fatalities




# Total Number of Child Fatalities by Manner of Death, 2013-2014





### Unintentional Firearm Deaths, 2013-2014







#### Case Study: Homicide by Malnutrition

#### **Case Summary**

- Baby was 14 months old at time of death
- Father left baby home alone for up to 12 hours per day
- Father noted that baby was deteriorating, but sought no medical treatment
- Father returned home from work to find baby deceased
- Father put baby in trash bags and tossed into woods
- Following unsuccessful suicide attempt, father confessed to LE
- Father plead guilty to involuntary manslaughter, negligent homicide, child endangerment, obstruction of justice, and making a false statement
- Father sentenced to life in prison



#### Case Study: Train vs. Pedestrian

#### **Case Summary**

- 16-year-old girl and best friend made a suicide pact and posted their intentions on social media
- 16-year-old also wrote poetry about suicide, father did not think she was writing about herself
- Friends did not take the suicide posts seriously
- 16-year-old posted on social media that there are directions on her cell phone from her house to the nearest train tracks
- 16-year-old and best friend found deceased on train tracks after train conductor was unable to stop the train in time
- Father later acknowledged that 16-year-old seemed depressed following a break-up



#### Prevention
