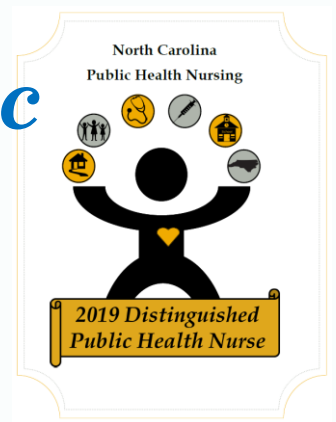

### **Eligibility for Nomination**

Nominees must have a minimum of three years of public health nursing practice and be currently practicing as of date of nomination in a

- NC Health department;
- NC School of Nursing (BSN, MSN, DNP, PhD courses); or
- NC School of Public Health.

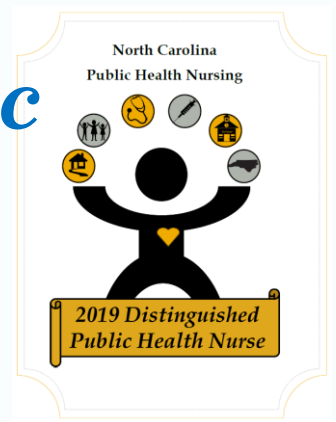
### **Categories/PHN practice area**

- Local Health Department Tier 1 - Direct-patient care
- Local Health Department Tier 2 - Supervisor/manager/coordinator
- Local Health Department Tier 3 - Director of Nursing or lead agency PHN, Assistant Health Director, or Health Director
- NC DPH Nurse Consultant or Nurse Supervisor
- Faculty Public Health Nurses working in a NC University

## Standards

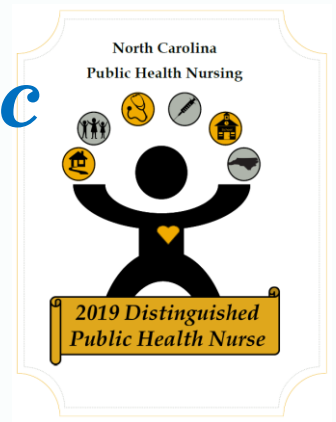
### Completing the Standards Questions

- FOR BEST RESULTS: First compile your answers in a Word document and assure they meet the required maximum 500-word count limit, then copy/paste your answers into the survey.
- Please provide a description of how the nominee demonstrates the Professional Standard(s). We need to hear about the nominee's work *and its impact*. **NOTE: Only one Standard is required per nomination.**
- Do not use any icons, logos, or other non-tradition key characters in your answers. **PHN, LHD, and DPH** are the only acceptable abbreviations.
- Do not use any identifying descriptors (name, agency name, etc.) in your response. You must replace all identifiers with "Xxxxxxx" or "This person" or "He/She."
- Note: If a person is nominated for more than one Standard, the average score for all responses will be used.

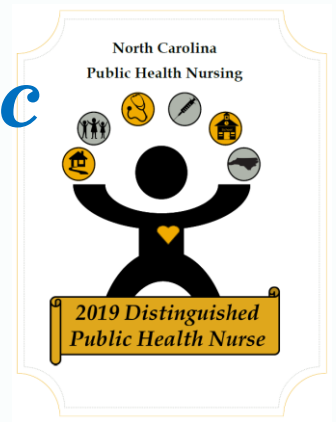


## **Helpful Hints!**

- The nomination survey must be completed once it is started - you cannot save your work and return at a different time
- All information must be submitted, and all questions answered, for a nomination to be considered.
- Because of limitations of the SurveyMonkey platform, you *may* not be able to see your entire answer. Therefore, it is recommended that you answer the questions in a Word document and verify their completeness before copying/pasting your response(s) into this form.
- A picture/headshot must be uploaded into the nomination survey if the nomination is to be considered. The photo must be in JPEG, JPG, PNG, or GIF format and **MUST** include the nominee's **FULL NAME** in the file name. **NOTE:** Only photo files up to 16 MB can be loaded.
- All nominees must be practicing at the time of nomination and expected to be practicing in Fall 2019 when the awards are distributed.
